INFORMATION FOR DELEGATIONS

A. INTERGOVERNMENTAL BOARD ON CLIMATE SERVICES (IBCS)

1. Historical summary of the GFCS

At the World Climate Conference-3, held in Geneva on 31 August-4 September 2009, Heads of States and Governments, Ministers and Heads of Delegations of over 150 countries and 70 organizations unanimously decided to establish a Global Framework for Climate Services to better serve society's need for accurate and timely information on climate.

The Conference mandated the Secretary-General of the World Meteorological Organization to set up a High-level Taskforce of independent advisors. An intergovernmental meeting held on 11-12 January 2010 endorsed the Taskforce composed of 14 high-ranking personalities. The Taskforce completed its report outlining the components of the Framework, options for governance and an implementation plan and submitted it for adoption to the Sixteenth session of the World Meteorological Congress in May 2011 (Cg-XVI). Cg-XVI decided to convene the first Extraordinary Session of the World Meteorological Congress to discuss the implementation and governance of the GFCS.

The Extraordinary Session held in October 2012 adopted the draft Implementation Plan of the GFCS, established the Intergovernmental Board on Climate Services as an additional body accountable to Congress under Article 8(h) of the Convention of WMO and requested the Secretary-General of WMO to convene the first session of the Intergovernmental Board on Climate Services as soon as possible (IBCS-1). IBCS-1 will be held from 1 to 5 July 2013.

2. TERMS OF REFERENCE OF THE INTERGOVERNMENTAL BOARD ON CLIMATE SERVICES

Annex 1 to Resolution 2 (Cg-Ext.(2012))

In accordance with the Annex 1 to Resolution 2 (Cg-Ext.(2012)) these terms of reference specify functions and responsibilities, membership, mode of operation and financing of the Intergovernmental Board on Climate Services.

I Mandate of the Board

1. The Intergovernmental Board on Climate Services (hereunder referred to as the "Board") shall operate within the mandate of WMO, and under the authority and guidance of, and be accountable to, the World Meteorological Congress, which will decide on policies, principles, overall strategy and key budget parameters. The Board shall oversee and provide the overall management of the development and implementation of the Global Framework for Climate Services (GFCS) and coordination at the global and regional levels.

II Functions of the Board

2. The Board shall discharge its mandate through the following specific functions:
 - (a) To implement the resolutions and decisions of Congress relating to the GFCS;

- (b) To consider, as appropriate, relevant decisions and recommendations of partner organizations participating in the GFCS;
- (c) To make recommendations to the constituent bodies of WMO and to partner organizations, based on Memoranda of Understanding or working arrangements of WMO with these organizations, on matters relating to the GFCS;
- (d) To develop, for consideration by Congress, international standards, recommended practices and guides for methods, procedures and techniques for the production of climate information and provision of climate services;
- (e) To guide, monitor and evaluate GFCS implementation progress;
- (f) To foster, facilitate and develop proposals for formal mechanisms, under Articles 25 and 26 of the Convention of the World Meteorological Organization, for active engagement and contribution of, and coordination among, the Framework stakeholders: United Nations system organizations, international intergovernmental and non-governmental institutions, regional organizations and funding agencies;
- (g) To maintain and make available a compendium of high-priority projects and initiatives consistent with the Implementation Plan at global, regional and national levels, funded by the GFCS Trust Fund as approved by the Board and other multilateral funds, and to establish a voluntary reporting mechanism for those projects and initiatives carried out through unilateral, bilateral and other efforts. The identified gaps and priorities could facilitate effective resource mobilization and overall accounting of GFCS implementation; these activities should address specific gaps and priorities identified in the GFCS Implementation Plan, which will facilitate the overall accounting of GFCS progress and ensure a strategic approach in global efforts;
- (h) To review the GFCS strategy, objectives and targets, and the Implementation Plan and associated budget on a regular basis and present its recommendations thereon to Congress;
- (i) To oversee the financial and institutional resources allocated to the Framework through the GFCS trust fund, and to note those additional resources made available in the budgets of partner organizations and by Members engaging directly in bilateral activities;
- (j) To report to the World Meteorological Congress on all the decisions and recommendations adopted by the Board, particularly on any recommendations of the Board requiring financial support or implementation by WMO Members, proposals requiring action by other WMO bodies or formal relations with other organizations as provided in Article 26 of the Convention of the WMO;
- (k) To perform such other functions related to the GFCS as may be conferred on it by Congress;
- (l) To ensure country ownership of climate information and climate services and products of the GFCS through establishment of an approval mechanism that ensures the full engagement of and approval by national focal points of data and reports of any other GFCS product of relevance to their Members.

3. The Board shall establish its subsidiary bodies to address in particular capacity building, and define their terms of reference, designate chairs and select membership for the subsidiary bodies from amongst experts nominated by WMO Members with due regard to the principle of equitable geographical representation and special attention to gender balance.

4. The Board shall establish a Management Committee at its first session to carry out the decisions and requests of the Board in the intersessional period. The Management Committee shall be composed of the Chair, the Vice-Chair and Members' representatives from each WMO Regional Association and respecting equitable geographical representation and paying special attention to gender balance.

B. THE FIRST MEETING OF IBCS

1. Convening

In accordance with a decision taken by the Extraordinary Session of the World Meteorological Congress (Geneva, October 2012), the IBCS has been convened to meet from Monday, 1 July, to Friday, 5 July 2013 in Geneva.

2. Composition

In accordance with resolution 47 (Cg-XVI) and resolution 2 (Cg-Ext(2012)), the Intergovernmental Board on Climate Services (IBCS) is an additional body accountable to the Congress under the Article 8 (h) of the Convention of the WMO. IBCS is composed of designated representatives of WMO Members. WMO Members nominate their delegates through credentials. The other participants are as follows:

- (a) Observers from non-Member States and Territories maintaining their own Meteorological or Hydrometeorological Service, as invited by decision of the Members;
- (b) Presidents of technical commissions of the Organization invited in accordance with Article 19 of the Convention;
- (c) Representatives of the United Nations and its specialized agencies, and other intergovernmental organizations, invited by virtue of existing agreements, working arrangements or other provisions for reciprocal representation;
- (d) Representatives of non-governmental international organizations to which consultative status with WMO has been granted by the Executive Council;
- (e) Representatives of other non-governmental international organizations invited in accordance with the provisions of General Regulation 19;
- (f) Individual experts invited in a personal capacity in accordance with Article 7 of the Convention and General Regulation 19.

3. Credentials of delegations

Mutatis mutandis Regulation 21 of the General Regulations, each Member should, if possible, communicate to the Secretary-General the names of the persons composing its delegation to the IBCS, indicating which of these shall be regarded as its principal delegate.

Besides this communication, a letter giving these particulars and otherwise conforming with the provisions of the Convention and of these Regulations and signed by, or on behalf of, an appropriate governmental authority of the Member shall be sent to the Secretary-General or handed to his representative at the session and shall be regarded as appropriate credentials for the participation of the individuals named therein in all activities of the IBCS.

The same procedure shall apply as regards the credentials of observers representing non-Member countries.

The credentials of observers representing international organizations shall be signed by the competent authority of the organization concerned.

All credentials that have not been sent to the Secretary-General should immediately, on arrival, be deposited by delegations with the officer-in-charge of credentials at the Conference Registration, Information and Documentation Desk. All delegates and observers will have to be registered either online in advance or upon arrival at this desk and will receive their badges, which will constitute the pass for admission to the meetings. These passes are personal and non-transferable.

4. Admittance to meetings – entry passes

(a) Delegations

Only holders of passes issued by the Conference Registration, Information and Documentation Desk will be admitted to meetings. All passes are strictly personal and non-transferable.

All participants will receive their passes upon arrival; they are expected to carry them at all times and to present them at the request of Security or Conference Services staff.

Members of Permanent Missions in Geneva holding UN passes shall be admitted.

(b) Press

Media correspondents, photographers and camera operators should first contact the Communications and Public Affairs Desk before proceeding to the Conference Registration, Information and Documentation Desk, where the passes will be issued for them.

(c) Public

The public may obtain passes for public meetings by applying to the Conference Registration, Information and Documentation Desk. These cards will be issued according to the space available. They are provided exclusively for admission to the public gallery and should be presented at any time at the request of Security or Conference Services staff. Plenary meetings and working committee meetings will be public; any meetings of other committees and subcommittees will normally be private.

All participants are requested to register online at <http://ibcs-1.wmo.int/registration> until 22 June 2013.

5. List of participants

A provisional list of delegates and observers will be distributed shortly after the beginning of the session. This list will be revised and redistributed upon final registration of all participants.

Delegations are requested to notify the Conference Registration, Information and Documentation Desk of any changes in the composition of the delegation during the session.

6. Opening of the session

The formal opening of the IBCS will take place at 9.30 a.m. on 2 July 2013 at the International Conference Centre – Geneva (17, rue de Varembé), following a Dialogue on practical action that will be held on 1 July 2013, starting at 9.30 a.m.

7. Agenda

The annotated provisional agenda for the IBCS meeting is given in IBCS-1/Doc. 1.3(2), REV. 1, posted at the IBCS website (<http://ibcs-1.wmo.int/home>). It will be submitted for approval by IBCS as soon as possible after the opening of the session. The tentative work plan is available at the IBCS website.

8. Time and place of meetings

A daily timetable of meetings will be available on the IBCS website. The timetable will be displayed on notice boards in the lobby as well.

Plenary meetings will be held in Salle I. Delegations will sit in alphabetical order based on the names of the Members of the Organization as spelled in French, starting from the front of the hall and beginning with Afghanistan. A plan showing the places of delegations and observers will be posted at the entrance. Seating arrangements will be made in accordance with information received by the Secretariat prior to the session.

Small conference rooms will be available for meetings of the Credentials Committee, the Nomination Committee, the Coordination Committee, subcommittees and side events. The daily allocation of schedule of these meetings and rooms will be announced in the IBCS website and on the electronic notice board in the entrance hall.

9. Documents

The presentation of the IBCS-1 session documents and organization of the work of the session will be similar to those of Extraordinary session of the World Meteorological Congress (October 2012).

It is to be noted that the proceedings of the sessions will be recorded.

Detailed minutes of plenary meetings will not be taken unless requested by the plenary for particular deliberations to be recorded formally.

A session e-mail mailbox will be provided (plenary@wmo.int) to allow participants to send substantive and/or editorial comments on documents to the Secretariat. It is required to mention the document reference in the subject of the e-mail.

10. Documents submitted by delegations

Documents and written inputs submitted by a delegation should be in one of the six official and working languages of the Organization and must be submitted in the name of the Member(s) concerned and not in the name of an individual. Documents will be channelled through the Secretary-General of the WMO or secretaries of committees as appropriate.

11. Distribution of documents

The session will be conducted in a paperless mode. All documents and their subsequent draft versions will be posted on the IBCS website. CICG is equipped with wi-fi, allowing delegates with notebooks to electronically access documents as necessary. The distribution of printed copies of selected documentation shall be done only upon request.

12. Working languages

In accordance with General Regulation 118, the official and working languages of the Organization are Arabic, Chinese, English, French, Russian and Spanish. The documentation will be translated into these languages. Simultaneous interpretation into these languages will be provided for the plenary meetings.

13. Records of meetings

The audio recordings of plenary sessions will constitute the verbatim records. If required, written minutes of plenary meetings will be prepared on the basis of audio recordings and notes taken by the Secretariat.

Delegates who wish to read a statement should supply it in advance for the interpreters. These statements should be handed to the Conference Registration, Information and Documentation Desk together with an electronic version to be sent to cnf@wmo.int.

Delegates are requested to hand over to the Secretariat representative texts of other statements or proposed amendments to the texts in the documents. These texts could also be sent to the generic e-mail: plenary@wmo.int.

No records will be taken of meetings of the working committees or the subcommittees.

14. Report of the session

The provisional edition of the abridged report of IBCS-1 will be made up of all documents, i.e. both general summary and resolutions approved by IBCS-1 in plenary meetings. It will also include the list of participants.

15. Press and public information

Within the limits of available space and upon presentation of entry passes, accredited representatives of the media will be admitted to all plenary meetings. Committee and subcommittee meetings are normally not public. Documents of the session will be available at <http://ibcs-1.wmo.int/in-session-document-availability>.

All inquiries concerning public information, including requests for interviews, should be referred to the Communications and Public Affairs Desk (cpa@wmo.int).

16. Secretariat

A list of the Secretariat offices, with office and telephone numbers, will be posted on the IBCS-1 website.

The Secretariat of the World Meteorological Organization (7 bis, avenue de la Paix, tel. +41 (0)22 730 81 11, wmo@wmo.int) will be open to visitors every weekday.

17. Delegates' mail – lost property

The Conference Registration, Information and Documentation Desk will collect and deliver mail addressed to participants. The same desk will also deal with lost property.

C. FACILITIES AVAILABLE IN THE INTERNATIONAL CONFERENCE CENTRE – GENEVA

1. International Conference Centre – Geneva (CICG)

The Conference Centre is located near the Place des Nations. A plan showing the location of the CICG, the WMO headquarters building and other international organizations can be found at <http://www.cicg.ch/en/>. The conference rooms are situated in the centre of the Conference Centre. The way to the various rooms will be indicated by signboards. Conference Services staff will be available to assist delegates. Personal computers with Internet connections will be at the disposal of participants in the Conference Centre. The Conference Centre has a wi-fi system for wireless connection of computers to the Internet. Instructions for connectivity will be available at the Conference Registration, Information and Documentation Desk. It is recommended that participants bring their own plug adapters to enable them to plug into Swiss power sockets. A limited number of adapters will be available from the Conference Registration, Information and Documentation Desk. There are no hard-wired Internet connections in the conference rooms. Cell phones should be switched off in the conference rooms.

2. Access to the CICG

Entrance to the building is through the main doors at 17, rue de Varembé.

3. Parking facilities

Parking at and around the main entrance of the Conference Centre is not allowed. In the streets adjoining the Conference Centre, parking is available for limited periods only.

There is, however, a large underground car park (“Parking de la Place des Nations”) open day and night, in the vicinity of CICG near the International Telecommunication Union (ITU) headquarters building. A limited number of entrance cards will be available for purchase from the Conference Registration, Information and Documentation Desk.

4. Local transportation and taxis

Bus numbers 5 and 8 and tram numbers 13 and 15 stop at the nearby Place des Nations and run to and from the centre of the city and the railway station (Place Cornavin). This service connects with all the Geneva tram, trolleybus and motorbus routes. In addition, bus numbers 11 and 22 pass close to the Conference Centre, connecting the Jardin Botanique/Place des Nations with Bout du Monde and Carouge, respectively. Taxis can be obtained through the Conference Registration, Information and Documentation Desk.

5. Post and telecommunications

There is a Post Office to the left of the rue de Varembé entrance to the Conference Centre.

Telephone booths are located at various points in the building. Phone cards or credit cards may be used.

The fax number of the Conference Centre is +41 (0)22 791 90 64. Fax messages may also be sent to the WMO Secretariat (+41 (0)22 730 81 81).

6. Office accommodation in WMO building

A limited number of offices will be made available in the WMO building for rental during IBCS-1. Delegations wishing to rent office facilities are requested to send a request specifying their needs to the Conference Services (cnf@wmo.int).

7. Bank

A branch office of the Union de Banques Suisses (UBS) is located on Chemin Louis-Dunant across from the Conference Centre.

8. Cloakroom

An unattended cloakroom is available to delegates in the entrance hall of the Conference Centre.

9. Quiet room

A quiet room for meditation, prayer, retreat and reflection will be available to delegates on the 3rd floor of the CICG, in room 20.

10. Restaurant, bar and cafeteria

A restaurant, bar and cafeteria are available in the CICG. Arrangements can be made for the organization of receptions through the Conference Registration, Information and Documentation Desk.

11. Medical service

A medical service is available at the "Permanence Médicale" located in the immediate vicinity at 9A, rue de Vermont, which is open 24 hours, 7 days a week (Tel.: +41 (0)22 734 5150). For medical emergencies there is a first-aid station located at CICG.

12. Duty-free fuel and shopping

In order to obtain duty-free shop passes and cards for supply of duty-free petrol, delegates should apply to the Conference Registration, Information and Documentation Desk. Cards granting the right to buy duty-free fuel must be returned upon expiration.

13. Travel and entertainment

Delegates may make any travel arrangements or reservations for their return journey through the accredited travel agency located at WMO Headquarters; the American Express Travel Agency, tel.: +41 (0)22 730 80 15, e-mail: ax.wmo@aexp.com.

Information relating to customs formalities and visas, as well as to local travel, weekend resorts, sports, theatres, performances and other activities can also be obtained from the travel agency.
